**ORDER**

**Subject: Resorting to malpractice of cheating by impersonation in Sub-Inspector in Delhi Police, CAPFs and ASI IN CISF Examination - 2016 -Cancellation of Candidature & Debarment**

**WHEREAS**, Shri Rinku, S/o Shri Satbir residing at VPO Behlba (Bajan) Teh. Meham Distt Rohtak, Haryana-124120 was a candidate bearing Roll No. 1203001765 for **Sub-Inspector in Delhi Police, CAPFs and ASI IN CISF Examination - 2016** conducted by Staff Selection Commission (hereinafter called the Commission), which was notified in the Employment News/ Rozgar Samachar dated 09.01.2016; and,

2. **WHEREAS**, Shri Rinku was provisionally recommended for appointment to the post of SI in SSB through the aforesaid examination; and,

3. **WHEREAS**, the Commission before forwarding the dossier to the appointing authorities/indenting departments undertakes detailed scrutiny and examination of documents submitted by the candidate and also of their signature, Left Thumb Impressions, photo and hand writing samples available on the various documents of the written examination and also those obtained during verification of documents for the aforesaid examination; and,

4. **WHEREAS**, the Commission *prima facie* noticed, during such scrutiny and examination apparent mismatch between signatures, Left Thumb Impressions, Photo and hand writing samples available on the various documents of the written examination and also those obtained during verification of documents for the aforesaid examination; and,

5. **WHEREAS**, Shri Rinku vide Memorandum of even number dated 09.11.2017 was directed to attend this office on within 15 days of issue to this Memorandum along with all original documents and ID proof for explaining the reason of differences in handwriting, Signature, LTI and submitting handwriting, signature and Left Thumb Impression as specimen/ sample failing which

[i] his/her candidature shall be cancelled;

[ii] he/she will be debarred from examinations of Commission for a period of 3 years: and,

6. **WHEREAS**, Shri Rinku didn't attend this office for explaining reason of differences in handwriting, signature, photo and Left Thumb Impression. He was also informed telephonically but again he did not appear and it is reasonably assumed that he has nothing to represent; and,

7. **WHEREAS**, the Commission, the Competent Authority in the matter has made a conscious decision with a view to protecting the integrity of the selection process and to prevent candidates who are *prima facie* found to indulge in unfair means in such examinations from entering into service through manipulating practices; and,

8. **THEREFORE**, candidature of Shri Rinku for aforesaid exam is cancelled and is debarred from appearing in the Commission's examinations for a period of 03 years as per details given below-
