List of provisionally short-listed candidates in respect of 40(UR-24, SC-04, ST-02 & OBC-10) vacancies for the post of Investigator Gr.II in Labour Bureau, Chandigarh advertised vide cat. No.NWR-5 of Advertisement No.SSC/NWR-3/2014

It is brought to notice of the candidates who applied for the post of Investigator Gr.II in Labour Bureau, Chandigarh advertised vide cat. No.NWR-5 of Advertisement No.SSC/NWR-3/2014 that 1035 candidates have been provisionally short-listed for written examination to be held on 23.07.2016(FN) at Chandigarh as Government has dispensed with the interviews for all Group 'B' & 'C' posts. Corrigendum/notice for revised scheme of examination (i.e. OMR based written examination) is also placed on the website. Admit cards for written examination will be uploaded on website 10 days before the conduct of examination.

Essential Qualifications for the post as per advertisement are:-

- (i) Bachelor's Degree with Statistics or Mathematics or Economics or Commerce as one of the subjects from a recognized University.
- (ii) Certificate/Diploma Course in Computer Operation or Software from a recognized Institution.

(The post is identified suitable for PH {OH(OA, OL), HH & VH(LV, B)} candidates. One vacancy is reserved for OH category.)

Age Limit - Not Exceeding 30 years

(Relaxable by 5 years for Central Government Employees who have completed 3 years continuous service on regular basis as on closing date of application. Relaxation in age for SC/ST/OBC/PH is mentioned at para No. 7(A).)

Following Criteria (on the basis of EQ-I as mentioned above) has been adopted by the Commission for short-listing - :

UR – 60% & above marks in EQ-I
OBC - 60% & above marks in EQ-I
SC – 60% & above marks in EQ-I
ST – 55 % & above marks in EQ-I

Note :- The list contains the candidates who fulfil the criterion of marks in EQ-I and Age Limit as mentioned above.

If any candidate who fulfil the criterion of EQ-I and Age Limit (as mentioned above) but has not been included in the list inadvertently, he/she may represent with all necessary documents for consideration of his/her candidature by **04-07-2016** to the Assistant Director, Staff Selection Commission (NWR), Ground Floor, Kendriya Sadan, Sector – 9, Chandigarh via mail on E-mail ID - sscnwr.rep.sp@gmail.com or on fax No.0172-2742144. No representation shall be entertained after **04-07-2016**. Representation without necessary details viz. roll number, name, necessary documents for consideration of his/her candidature shall also not be entertained.
