

**SHOW CAUSE NOTICE**

**WHEREAS**, Shri Sanju, Roll No.1601113954, is a candidate of Combined Higher Secondary Level Exam 2017 notified in Employment News dated 18.11.2017 and the Commission had issued admit card for appearing in Tier-I of above mentioned examination of 16/03/2018 at Vinayak Web Solutions Pvt. Ltd., Chandigarh; and

2. **WHEREAS**, the Commission was informed that Sh. Sanju, Roll No. 1601113954 was allotted seat/System No. 136 and Sh. Sandeep Kumar, Roll No. 1601093954 was allotted seat/system No. 159 after Biometric Registration but they exchanged their seats with malafide intention of cheating in the examination. The same was confirmed through CCTV recording of the venue and it was confirmed that both candidates exchanged their seat with each other. They were caught during random checking; and,

3. **WHEREAS**, as per Para 17 of Notice for said exam,- " Without prejudice to criminal Without prejudice to criminal action/ debarment from Commission's examination wherever necessary, candidature will be summarily cancelled at any stage of the recruitment in respect 14 of candidates found to have indulged in any of the following:-

- (i) Involved in malpractices.
- (ii) Using unfair means in the examination hall.
- (iii) Obtaining support for his /her candidature by any means.
- (iv) Impersonate /Procuring impersonation by any person.
- (v) Candidature can also be cancelled at any stage of the recruitment on any ground which the Commission considers to be sufficient cause for cancellation of candidature.."

4. **AND, THEREFORE**, Shri Sanju is directed to appear in SSC(NWR), Chandigarh to show cause why his candidature should not be cancelled and be debarred for 3 years as he was involved in malpractice and cheating by exchanging his seat with Sh. Sandeep Kumar. If the candidate does not appear within 10 days of issue of this letter, it will be presumed that he has nothing to represent and further action to cancel his candidature and to debar him will be taken. If he appears within stipulated period, samples of his handwriting, signature, LTI will be taken besides taking his videography. Thereafter the Commission would take appropriate decision which may include registering of FIR by handing over records and CCTV Footage to Police for starting proceeding against criminal section.
