- (ii) **Undertaking** as per the format annexed to this notice.

However, such exemption is not available for the posts where either Computer Proficiency is prescribed (as mentioned at Para 13.8.9) or where DEST is prescribed (as mentioned at Para 13.8.10.4) except for the post of the Tax Assistant in CBDT, for which exemption from attempting DEST is available. All other PwD candidates are not eligible for exemption from the Skill Test (DEST).

Alternatively, the candidates may also report at the venue of Tier-II on date of their Paper-I along with aforementioned documents (**Original & Photocopy**) for seeking exemption from DEST.

The candidates are required to produce all the aforesaid documents in original at the time of Document Verification or any other time as and when called by the Commission. If any candidate fails to produce the same during Document Verification, Commission would cancel the candidature of such candidate for this exam and such candidate will have no claim against the Commission's decision.
