Special Recruitment Drive for persons with disabilities (PwD) to the Post of Multi Tasking (Non-Technical) Staff (MTS) in Different States And Union Territories, 2015-final result (for Chandigarh).

Staff Selection Commission conducted Written Examination (Paper-I) on 10th January 2016 at different centers in North West Region. Based on performance In the Written Examination, candidates were called for Paper-II. The candidates who qualified in Paper-II were called for document verification.

2. Keeping in view the vacancy position, category-wise details of the qualified candidates for appointment are:-

NOTE I: As per Notice of Examination, candidates intending to apply for the post in more than one State/UT had to submit separate applications for each State/UT to the Regional office having jurisdiction over such State/UT. Therefore, only candidates who had applied to the concerned Regional Office having jurisdiction over the concerned State/UT were considered

NOTE II: Paper-II is qualifying in nature only. Only candidates qualifying in Paper-II were considered for selection.

4. RESOLUTION OF TIE CASES

In cases where more than one candidate secure the equal aggregate marks, tie will be resolved by applying the following methods one after another:-

- (1) By referring to the marks in Part-III of the objective type paper.
- (2) By referring to marks in Part-II of the objective type paper.
- (3) Date of Birth i.e. the candidate older in age gets preference.


(4) By referring to the alphabetical order of the names taking first name in to consideration

(Marks in Paper-I of candidates who qualified in Paper-II and appeared for document verification have been used for preparing the final result)

5. For candidates belonging to reserved categories for whom certain percentage of vacancies are reserved as policy of Govt. the category status is indicated against their Roll No. It is important to note that some of them have been declared qualified only in the category mentioned against their Roll Nos. If any candidate does not actually belong to the category mentioned against his/her name, he/she may not be eligible to be included in the list.

6. The candidates whose Roll nos. figure in the list are subject to their fulfilling all the eligibility conditions/requirements as prescribed for the post in the Notice of the Examination.


